- (vii) In the event that any alterations to the Property and/or any matter added to the Property after the completion of the sale and purchase of the Property will hinder the Vendor from carrying out the remedial work of the defects (in which respect the Vendor's assessment and decision shall be final, conclusive and binding absolutely), the Purchaser shall be responsible for removing such alterations or additions prior to the commencement of the remedial works and restore such alterations or additions after completion of the remedial works at the Purchaser's own cost. Should the Vendor accept the Purchaser's application for the Early-Move-in Benefit and shall decide to grant a Licence to the Purchaser, the Purchaser shall enter into a licence agreement in the Vendor's prescribed form and content without amendment (the "Licence Agreement") no later than 30 calendar days prior to the commencement date of the relevant licence period ("Licence Period") under the Licence Agreement, provided that upon the signing of the Licence Agreement by the Purchaser, the Purchaser shall have paid to the Vendor a total of not less than 15% of the purchase price of the Property in accordance with the formal agreement for sale and purchase. The Licence Period shall commence on the date designated by the Vendor and specified in the Licence Agreement ("Licence Commencement Date") and the Licence Commencement Date shall be no earlier than the 60th day after the date of the Preliminary Agreement.
