Should the Vendor accept the Purchaser's application for the Early-Move-in Benefit and shall decide to grant a Licence to the Purchaser, the Purchaser shall enter into a licence agreement in the Vendor's prescribed form and content without amendment (the "Licence Agreement") no later than 15 working days prior to the commencement date of the relevant licence period ("Licence Period") under the Licence Agreement, provided that upon the signing of the Licence Agreement by the Purchaser, the Purchaser shall have paid to the Vendor a total of not less than 20% of the purchase price of the Property in accordance with the formal agreement for sale and purchase. The Licence Period shall commence on the date designated by the Vendor and specified in the Licence Agreement ("Licence Commencement Date") and the Licence Commencement Date shall be no earlier than the 45th day after the date of the Preliminary Agreement.
